The April 2024 meeting of the Chamber of Commerce was called to order at 12:00 by President Tim Reddick. Attendees (in person and on Zoom) were Executive Director Donna Besaw, Directors Connie Stowell, Ray Babowicz, CJ Fitzgerald, Melissa Simione, Dianne Cocco, Brooke Plowman, Shari Barnhart, Michelle Blackburn, Donna Lawrence, Christian Gillan and member Rachel Hunter from the Tribune Press

The minutes of the March meeting were approved by a motion from Brooke and seconded by Ray.

Executive Director Donna Besaw gave the treasurer's report with dues and advertising received of \$9,043 and expenses totaled \$926 leaving a balance of \$35,589 in the checking account with \$34,414 as Chamber share and \$1,175 in Eldon Conklin memorial fund. CJ made a motion to accept the treasurer's report and Christian seconded, motion carried.

Correspondence: Donna Besaw reported that the Chamber received an April Elks Club newsletter, a sample directory as an advertisement, several emails and two magazines.

Committee Reports: The DBA list for February has not yet been received. Flowers need to be delivered to Fred Scozzafava of Gouverneur Auto, Peaceful Finances with Mickael and Gouverneur Foundation (Lauren French - President).

Old Business: Plans for Welcome to Gouverneur Sign Tim will check with BOCES. Donna showed the directors the sample ad that will be in the Local Food Guide by Gardenshare.

New Business: Resignation Received from Chelsea Donovan. Connie made the motion to accept Chelsea's resignation, CJ seconded, and motion carried. Ray will check with Gouverneur Hospital to see if they have a representative that would like to join the board. The Letter Inviting New Business to Gouverneur was read and approved by the board. Donna will type the letter on Chamber letterhead and a

directory will also be enclosed when sent. Bench or Tree in Memory of Past Chamber Directors was again discussed. The benches in the park will all be the same as the village wants benches with no maintenance. We may be able to install a plaque on one of the benches and we will go to Brown's Jewelers to inquire about a new plaque. This will be discussed again next month. Solar Eclipse on April 8th will be observed in Gouverneur with the schools closing that day, but the Chamber nor village has any special events planned. Banquet Planning: Award of Merit this year will be awarded to Clark Porter. Pro Act will be our speaker that evening, directors will again bring door prizes and the tickets will be ordered or Donna will print them soon, once we know what the dinner and cost will be. It was decided that we will move the evening ahead by ½ hour so cocktails at 5:30 and dinner at 6:30. Donna will send Shari a list of the Gold & Silver members (Kinney Drugs remains Marble Member) so our website can be updated. Donna Lawrence will order the plaque, CJ is in charge of flowers and Connie will pick up banners and deliver them to Arne for updating. It was decided that we increase the price of the dinners by \$5.00 to cover our costs. Donna Lawrence made that motion, Donna Besaw seconded, and motion carried. Gardenshare Meeting on March 26^{th} for the vendors was held at the Gouverneur library but none of the chamber directors were available to attend. Farmer's Market can be held at the other end of the park, or they can move temporarily to the train depot on Main Street (Farley's lot) until the park is available. The only concern was if the insurance would cover them there. Donna checked and a small rider can be attached to our policy which would cover 'special events'. Flag Day will again invite vendors, but the Friends of the Library are not participating as organizers. We discussed renting a tent if the park and gazebo are not avaílable but was decided that we can probably use a 10 χ 10 tent if needed for inclement weather, but we'll discuss it again next month. Donna will see if we can get the vendor list from Kaitlin Morse. Christmas Parade: Donna was contacted by the reindeer farm that the reindeer are already booked for an event on December 7th. Donna has asked them for suggestions of anyone else that may be available and will also contact the DEC to see if they know of any reindeer. Business of the Month of April is United Construction and Forestry and the Student of the Month of March is Madison Kackison of Nurse Assisting. The next chamber meeting is May 6^{th} , and this meeting was adjourned at 12:49 by Connie.
